### Proposal

An Official Plan Amendment application from *Regeneration Areas* to *Mixed Use Areas* for a new GO Station as well as an intensified mixed-use development which would include mid-rise and tall buildings. The redevelopment of this site would be completed in multiple phases with new public streets, a new public park, and Privately-Owned Publicly Accessible Spaces (POPS). This proposal includes employment, residential, retail, and entertainment uses.

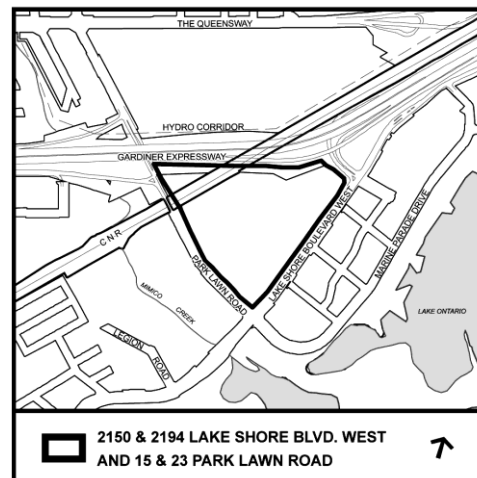
